DIVISION OF EMERGENCY MANAGEMENT AND HOMELAND SECURITY STATE
AND LOCAL CYBERSECURITY GRANT PROGRAM IN THE AMOUNT OF \$103,417.48
WITH A 20% COST MATCH OF \$20,683.49 WITH FEDERAL FUNDS TOTALING
\$83,733.99 AND PERMISSION TO APPLY AND ACCEPT, EXECUTE AND IF
NECESSARY, MODIFY ALL RELATED DOCUMENTS, CONTRACTS, AND SUCH
INSTRUMENTS AS DEEMED NECESSARY

WHEREAS, SLCGP allows entities to address cybersecurity risks and cybersecurity threats to information systems owned or operated by, or on behalf of, state, local, or tribal government; and,

WHEREAS, The SLCGP grant will fund training and software to promote an increase in cybersecurity, preparedness, and mitigation efforts for the City of New Haven, specifically, the Board of Education and local institution of academia. The project is seeking funding for a Firewall Assessment, External Network Assessment, Internal Network Assessment, and Reporting Services; and,
