Alder Hamilton, called the meeting to order at 6:02 p.m., August 31, 2017 in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Hamilton, Marchand, Colon, Paolillo, Morrison, Walker, Festa, and Reyes.
