### Meeting Minutes

*Alder Marchand, Chair called the meeting to order at 6:02 p.m., December 8, 2025, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Aids. Marchand, DeCola, Ferraro-Santana, Morrison, Walker-Myers, Hamilton, Furlow, and H. Smith. Also in attendance was Alder Marx.*

*Rebeca Bombero, Deputy Chief Administrator, came before the committee and spoke on the request.*

*Alder Hamilton asked how the residents would pay back their portion of the expense. Ms. Bombero explained.*

Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.

Shannon McCue, Director of the office of Policy, Management, and grants, came before the committee. Ms. McCue spoke about the September Monthly Financial Report.

Alder H. Smith asked if the city received reimbursements for the drug prescription plan. Ms. McCue said they did.

Alder Furlow asked if the savings from salaries was from vacant positions and the hiring freeze. Ms. McCue explained the saving.

Alder Furlow asked if the city planned to resume the car booting program for overdue car taxes. Ms. McCue said she didn't know.

No questions further were asked.

Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.

At 7:02 PM, on a motion by DeCola, seconded by Morrison, to close the public portion of the meeting. The committee voted unanimously in favor of the motion.

#### Committee Action:

1. Alder DeCola, seconded by Morrison, to move item 1 favorably. Alders Morrison,

*Ferraro-Santana, and Hamilton spoke in favor of approving this item. The committee voted by voice vote to approve the Kenter Place construction.*

*2. Alder Marchand reminded the committee that they were going to Passover item 2.*

*3. Alder DeCola, seconded by Morrison, to move item 3 favorably. Alders DeCola, Walker-Myers, and H. Smith spoke in favor of approving this item. Alder Marchand made a motion to amend Section 2 of the order, which he read to the committee. Morrison seconded the amendment motion. The committee, by voice vote, approved the amendment. The committee the voted, by voice vote to approve the amended contracts.*

*4. Alder DeCola, seconded by Morrison, to move item 4 for Read and File. The committee voted by voice vote to approve the Read and file of the October Monthly Financial Report.*
