Meeting Minutes

Alder Marchand, Chair called the meeting to order at 6:03 p.m., June 9, 2025, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Marchand, Morrison, Walker-Myers, Hamilton, Furlow, and Punzo.

1. ORDER OF THE NEW HAVEN BOARD OF ALDERS AUTHORIZING THE BOARD OF EDUCATION'S AGREEMENT WITH THE SUBSTITUTE TEACHERS CHAPTER OF THE NEW HAVEN FEDERATION OF TEACHERS, AFT LOCAL 933, AFT CT, AFL CIO FOR A SUCCESSOR COLLECTIVE BARGAINING AGREEMENT FROM JULY 1, 2020 TO JUNE 30, 2027.

Dr. Paul Whyte, from the Board of Education, came before the committee and spoke on the request.

Alder Punzo asked Dr. Whyte to explain how the substitute teachers were notified as to what school they were needed. Dr. White did so.

Alder Hamilton asked if the contract had been ratified by the union membership. Dr. Whyte said that the union had ratified the contract.

Alder Marchand asked how the Board of Education was going to make the payments for the teachers back pay. Dr. Whyte spoke on this

Alder Marchand asked what the city staff thought of this system. Dr. Whyte explained.

Alder Marchand asked what the financial impact of the back payments and how many people were covered. Dr. Whyte said that he did not know but he would get this information back to the committee.

No further questions were asked.

Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.

2. ORDER TO READ AND FILE THE UPDATED BUDGETARY AND FINANCIAL REPORTS FOR THE MONTH OF APRIL 2025 IN COMPLIANCE WITH ARTICLE VIII SECTION 5 OF THE CHARTER

Sharron McCue, Office of Policy, Management, and Grants Director came before the committee. Ms. McCue spoke to the committee about the April Monthly Financial Report.

Alder Hamilton asked about the insurance claims. Ms. McCue explained.

Alder Furlow asked about permits that had been granted and paid for but the projects were cancelled if the contractor would be refunded the cost of the permits. Ms. McCue said she didn't know but would get this information back to the committee.

No further questions were asked.

Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.

At 6:28 PM, on a motion by Furlow, seconded by Morrison, to close the public portion of the meeting. The committee voted unanimously in favor of the motion.

Committee Action:

1. Alder Marchand, committee chair, told the committee that item 1 needed to be voted on by the full Board of Alders in July and that he was keeping it in committee and requesting that it be discharged from committee at the July Board of Alders meeting. The committee approved this action.

2. Alder Furlow, seconded by Morrison, to move item 2 favorably for Read and File. The committee voted by voice vote to approve the April monthly be Read and File.

At 6:32 PM, on a motion by Furlow seconded by Morrison, the Committee voted to close the meeting.
