**ORDER APPROVING NEW HAVEN SMART MOBILITY LLC TO ESTABLISH AND  
OPERATE A PUBLIC BIKE SHARE SYSTEM WITHIN THE CITY OF NEW HAVEN**

WHEREAS, Vision 2015, the City Comprehensive Plan, envisions a city where everyone who lives, works, learns, or plays in New Haven has healthy, environmentally sustainable, and economically viable transportation options and recommends that the City "encourage private owners to locate publicly available bicycle sharing system throughout the city"; and

WHEREAS, the City Transformation Plan calls on the City to be a place that all residents have access to quality, affordable housing, infrastructure, and safe neighborhood spaces that promote well-being and community cohesion and specifically lists building "infrastructure that allows residents to use bikes and public transit more efficiently" as a strategy; and

WHEREAS, New Haven Smart Mobility LLC, is the vendor selected by the City of New Haven (the "City") after submitting a qualifying response to the City issued Bike Share RFP in August 2016 (the "RFP"); and

WHEREAS, the Bike Share system will be a joint effort between the City of New Haven and New Haven Bike Share LLC (the "Bike Share System"); and

WHEREAS, New Haven Smart Mobility LLC will install and manage the Bike Share System in the City; and

WHEREAS, the Bike Share System will have an initial roll out of not less than 30 bicycle stations and not less than 300 bicycles across New Haven and

WHEREAS, the Bike Share System is designed to maintain flexibility and room for growth as the program matures; and

WHEREAS, the RFP requires New Haven Smart Mobility LLC, to bring additional infrastructure to New Haven, such as public street furniture and bus shelter upgrades, and to provide mobility and data management to the City; and

WHEREAS, to cover the costs of the system, New Haven Smart Mobility LLC will use advertising and marketing sponsorship funds, such as home advertising.; and

WHEREAS, success for the Bike Share System means 1) increasing commuter and non-commuter bicycling trips originating and ending in New Haven; 2) increasing mobility

options for all New Haven communities; and 3) providing accessible and affordable bike share to vulnerable populations in New Haven that are not well served by other modes of transportation; and

WHEREAS, the City and New Haven Bike Share, LLC, propose to enter into "An Agreement Between the City of New Haven and New Haven Smart Mobility LLC" (the "Agreement") setting for the basic elements of the Bike Share System, (a copy of the Agreement is attached and incorporated by reference) and which Agreement provides for the initial installation of a Bike Share System with 30 bike share stations and 300 bicycles and a term of five (5) years, as well as terms for adding additional bike share stations and bicycles as the Bike Share System matures.


NOW THEREFORE, BE IT ORDERED, that the Agreement be approved together with all ancillary and supporting documents described or contemplated in the Agreement, including any license agreements, advertising revenue agreements, and all other instruments among the parties or with third parties as may be necessary to further the implementation of the of the Bike Share System (the "Ancillary Documents").

AND BE IT FURTHER ORDERED, that the Mayor of the City of New Haven (the "Mayor") be and hereby is authorized to execute and deliver on behalf of the City the Agreement in form substantially similar to that approved hereby and to execute and deliver the Ancillary Documents on behalf of the City of New Haven and that the City-Town Clerk of the City of New Haven is authorized and directed to impress and attest the official seal of the City of New Haven upon this Order, to the Agreement and, to the extent necessary, to the Ancillary Documents, provided that the Agreement shall be executed within ninety (90) days of this Order with a copy of the executed Agreement (and any Ancillary Documents whether concurrent with the execution of the Agreement or contemplated thereunder at any future date) filed with the Office of Legislative Services within seven (7) days thereafter, with any minor technical revisions to the form of Agreement hereby approved duly redlined.

AND BE IT FURTHER ORDERED, that the Mayor be and hereby is authorized an empowered to execute, acknowledge, and deliver such other documents as may be considered necessary or appropriate, from time to time, to implement and effect the intent and purposes set forth in the Agreement and this Order.


