My name is Sean Buskey, i'm writing you today in regards to my interest in joining the New Haven Peace Commission. i apologize for the delayed response, i have been dealing with a death in the family and lost track of certain tasks that i had due. So, i am 34, single male, born and raised in and around New Haven County, i have spent the majority of my adult life living in New Haven itself. I paint houses for a living, but have always been very interested in things such as politics, activism, & social justice movements. I am currently living at the New Haven Zen Center on Mansfield St, which is a zen buddhist temple that offers residential training for those who are serious about their spiritual practice, as i am. i was first made aware of the Peace Commission by our Abbott, Paul Bloom, who's wife, Millie, is a member.
