Alder Marchand, Chair called the meeting to order at 6:00 p.m., March 14, 2024, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Marchand, Ferraro-Santana, Morrison, Hamilton, Walker-Myers, Festa, Furlow, Hurt, H. Smith, and S. Punzo. Also present were Alders C. Smith and Wingate.

1. To hear PUBLIC TESTIMONY concerning the Mayor's Annual Budget for the Fiscal Year

2024 25.

Alder Marchand called the following people to come before the committee and testify. They were:

- 8. Mona Berman, of 78 Lyon Street, who spoke against the tax increase.

Alder Marchand asked three times if there was anyone else from the public who wished to testify, no one came forward

At 7:25 PM, Alder Marchand told the committee that they would take a brief recess.

At 7:35, Alder Marchand called the meeting back to order.

- a. City Clerk: Michael Smart, City Clerk, May Bey Reed, Assistant City Clerk, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke followed by Mr. Smart.

Alder Festa asked what their plans were for early voting. Mr. Smart explained their plans.

No further questions were asked.

b. Mayor's Office: Sean Mattison, Chief of Staff, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke followed by Mr. Mattison.

Alder Furlow if there were increase to the positions in the proposed budget. Mr. Mattison spoke on this.

Alder Festa asked when the last time was there was a Deputy Chief of Staff. Mr. Gormany spoke on this.

Alder Morrisson asked who does the Policy Analyst job. Mr. Mattison explained. if the drug costs were lowering. Mr. Gormany spoke on this.

No further questions were asked.

c. Registrar of Voters: Shannel Evans, Democratic Registrar of Voters, and Michael Gormany, Director of Management & Budget, came before the Committee. Ms. Evans spoke, followed by Mr. Gormany.

Alder Hamilton asked if the Tabulators were ready for the elections. Ms. Evans spoke about them.

Alder Furlow asked why the Republican Registrar of Votes was not present. Ms. Eveans was unable to answer this question.

Alder Festa asked if there was enough money in the budget to cover the costs for the early voting. Ms. Evans said there was.

No further questions were asked.

d. Fair Rent: Wildaliz Bermudez, Director of Fair Rent, Patricia King, Corporation Counsel, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke followed by Ms. Bermudez.

Alder Furlow asked if the commissioners were given training . Ms. Bermudez spoke on their training.

No further questions were asked.

e. Assessor's Office: Alex Pullen, Acting Assessor, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke about the city's grand list.

Alder Festa asked about the real property and the personal property. Mr. Pullen explained.

Alder Festa asked what they did about out-of-state licensed cars. Mr. Pullen explained the procedure.

No further questions were asked.

f. Finance/Other: Michael Gormany, Director of Management & Budget, and Kristy Sampieri, Controller, came before the committee. Mr. Gormany spoke followed by Ms. Sampieri.

Alder Festa asked about the pension actual return. . Mr. Gormany wasn't sure but would get back to the committee.

Alder Festa asked if they were planning to install solar panels on the Rout 80 facility. Mr. Gormany wasn't sure but would get back to the committee.

No further questions were asked.

g. Board of Alders/Legislative Services: Albert Lucas, Director of Legislative Services, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke followed by Mr. Lucas.

There were no questions.

At 9:52, Alder Marchand called a short recess.

At 10:05 PM, Alder Marchand called the meeting to order.

h. Corporation Counsel: Patricia King, Corporation Counsel, Rodrick Williams, Deputy Corporation Counsel, Catherine LeMar, and Michelle Duprey, from Corporation Counsels office, Wendella Ault-Batty, Director of Labor Relations, and Michael Gormany, Director of Management & Budget, came before the committee. Mr. Gormany spoke about Labor Relations, followed by Ms. Ault-Batty.

Mr. Gormany spoke about Corporation Counsel, followed by Ms. King.

Alder Festa asked if they knew what the penalties were collect by LCI. Ms. King said she didn't know, and that question would have to be answered when LCI came before the committee.

Alder Furlow asked how many litigators they have in the department. Ms. King explained.

No further questions were asked.
