Alder Evette Hamilton, Vice-Chair, called the public hearing to order at 6:05 p.m.

#### **PUBLIC TESTIMONY**

Alexandra Futty, 50 Woodward Avenue, spoke in support of her appointment to the Commission on Disabilities. Before moving to New Haven, she lived in Burlington, Vermont and served on the commission there. She is a person with a disability and is legally blind. Also, she is a teacher of students with visual impairment. Currently, she is getting her Ph.D. in Global Inclusion and Social Development.

In response to Alder Hamilton, Ms. Futty confirmed she knows when the meetings are. She is not available to attend the meetings until December due to her class schedule. She has already a meeting of the Commission on Disabilities to make sure it was a good fit for her. Also, she spoke with Gretchen, and they are discussing changing the meeting date. If they do not change the meeting date, she will be able to start attending.

In response to Alder E. Rodriguez, Ms. Futty confirmed she had served on the Burlington Commission on Disabilities for approximately 2½ years. The mayor of Burlington gave the commission to some funding, which they were able to use to form public / private projects such as a tactical map of the Lake Champaign and install
