Minutes

Alder Anna M. Festa, Chair, called the public hearing to order at 6:05 p.m. Present were Alders Anna M. Festa, Chair; Kampton Singh, Vice-chair; Sal Punzo; and Adam J. Marchand.

1. ORDER OF THE NEW HAVEN BOARD OF ALDERS APPROVING A PETITION REQUESTING LAND USE EXPANSION AND RECONFIGURATION OF THE NEW HAVEN DOWNTOWN CROSSING TO CREATE AND EXPANDED "TOWER AND GARDEN DISTRICT."

PUBLIC TESTIMONY

Katherine Grace, Architect; Valley Drive, Greenwich, presented the plans for the Tower and Garden District. Reviewed how there is \$16 billion grant funding available from transportation upgrades in Connecticut. A copy of the presentation is on file in the Office of Legislative Services.

In response to Alder Festa, Ms. Grace confirmed that she has not reached out to the director of Transportation, Traffic & Parking yet. Discussed how she has been in contact with Michael Piscitelli in Economic Development.

COMMITTEE ACTION

PUBLIC TESTIMONY

Steven Winter, Executive Director of Climate & Sustainability, presented this item and spoke of the importance of supporting this resolution to urge the President of the United States and Congress to create a Federal Climate Emergency Plan.

In response to Alder Festa, Director Winter confirmed that these requests are stronger when more towns support them. Reviewed how funding is available. Reviewed programs available, tax credits, and upfront rebates, which will be coming out in 2024.

Clara Dewey, Mechanics Street, Sunset Group, spoke in support of establishing a federal climate emergency plan, and the importance of acting quickly.

Chris Switzer spoke in support of establishing a federal climate emergency plan. Reviewed how New Haven is high risk for the effects of climate change. Discussed the importance of plans for transportation.

COMMITTEE ACTION

Alder Kampton Singh moved item # 2, seconded by Alder Sal Punzo. All the Alders spoke in favor of the item. The motion was unanimously approved, and the item passed.
