Meeting Minutes

Alder Marchand, Chair called the meeting to order at 6:00 p.m., April 21, 2022 in the Hillhouse High School Auditorium, 480 Sherman Avenue, New Haven. Present were Alds. Marchand, Hurt, Santiago, Douglass, DeCola, Morrison, Hamilton, Walker-Myers, Festa, Furlow, and Winters. Also in attendance were Alders Punzo and E. Rodriguez.

1. To hear PUBLIC TESTIMONY concerning the Mayor's Annual Budget for the Fiscal Year

2022 23.

Alder Marchand asked if there is anyone from the PUBLIC WISHING TO TESTIFY. The following people came forward.
