### Meeting Minutes

Alder Crespo, Chair called the meeting to order at 6:10 p.m., June 25, 2024, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Crespo, Douglass, Wingate, Marx, and Streeter. Alder C. Rodriguez was also in attendance

1. ORDER CONCERNING REAL PROPERTY TAXES OF MARIA L. ZAMBRANO ON MOTOR VEHICLE TAX ACCOUNT 805765

Alder Crespo asked if there was anyone present for this item. No one came forward
