


EPA's Purpose

Community Infrastructure and Land Use

Green Corridors

• Plant street trees, reduce heat islands, mitigate stormwater runoff, align with complete streets improvements

Community Gardens and Green Spaces

• Improve climate mitigation function of gardens and green spaces, and increase community connection to spaces

Environmental Monitoring

• Expand air quality monitoring to EJ neighborhoods

Climate-focused Zoning Ordinance Revision

• Changes in site requirements (reflective heat and tree cover)

Housing and Health

Energy Upgrades to Occupied Homes

• Retro-fit 1-4 unit owner-occupied homes and CBOmanaged residential buildings

Energy Upgrades to Affordable Housing Developments

• Energy saving and electrification measures in affordable housing projects (new construction or buildings under substantial renovation)
