As a proud New Haven resident of four years, I am seeking to become more actively involved in advancing equity and justice in the community I now call home. I am writing to express my strong interest in serving on the Commission on Equal Opportunities, an entity whose mission aligns deeply with my personal values and professional experience.

I bring a unique combination of legal expertise and strategic equity leadership. As an attorney, I have extensive experience litigating on behalf of marginalized communities, having served as a public defender at Brooklyn Defender Services where I represented parents accused of abuse and neglect. My clients were overwhelmingly from low-income, overpoliced communities—primarily Black and brown families—navigating a system that disproportionately regulated and surveilled them. This work sharpened both my legal acumen and my understanding of how systemic inequities manifest at the community level.

Beyond the courtroom, my career has centered on operationalizing equity within complex institutions, from government agencies to national nonprofits. At the NYC Department of Education, I worked in both teacher accountability and equal opportunity roles, investigating discrimination claims and ensuring compliance with civil rights laws. I later served as the inaugural Director of Diversity, Equity, and Inclusion at a public defender office, and currently lead racial equity strategy at Planned Parenthood Federation of America. In each role, I've worked to analyze the root causes of disparities and build systems that promote fairness, dignity, and access for all, rather than just temporary fixes.

I am deeply relational in my leadership approach and grounded in community-centered values. I believe that equity work is most effective when informed by those closest to the impact. I would bring this lens to the Commission's mission of fostering harmonious intergroup relations and identifying systemic barriers to opportunity in New Haven. It would be an honor to contribute to the Commission's critical work and help shape policies and programs that improve outcomes for all residents, particularly those who are often left behind.
