Meeting Minutes

Alder Marchand, Vice Chair called the meeting to order at 6:05 p.m., November 8, 2021 via webinar. Present were Alds. Marchand, DeCola, Morrison, Festa, Furlow, E. Rodriguez, Hurt, and Decker. Also present were Alds. Winters, Roth, and Sabin.

Patricia Clark, Director of Vital Statistics, Brook Logan, Deputy Director Health Department, Michael Gormany, Acting Controller, and Steve Librandi, Director of Human Resources. Mr. Gormany spoke on this request followed by Ms. Clark.

Alder Festa asked if these were tested positions. Ms. Clark said that they were.

Alder Festa asked if they still needed the Processing Clerks. Ms. Clark answered.

Alder Furlow asked how these new positions were in compliance with the Charter/Ordinances. Mr. Gormany spoke on this.

Alder Furlow asked if they needed state authorization. Ms. Clark explained.

Alder Rodriguez asked if they would still be long to the union. Ms. Clark said that they would.

Alder Rodrigues asked how long the current position had been vacant. Ms. Clark told her how long.

No further questions were asked.

Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.

Michael Gormany, Acting City Controller, Chief Rene Dominguez, Chet Sawicki, Director of Information Technology, Giovani Zinn, City Engineer, Assistant Chief Karl Jacobson, Rebecca Bombero, Deputy Chief Administrative Officer, and Captain John Healey came before the committee.

Mr. Gormany spoke on both transfer requests, followed by Mr. Sawicki and Chief Dominguez.

Alder Festa asked if the cameras would use facial recognition. Chief Dominguez spoke about this.

Alder Festa asked about why the need for a 3rd data center on the cloud. Mr. Sawicki answered the question.

Alder Festa asked if the cameras were mobile/revolving. Chief Dominguez answered.

Alder Furlow asked if the new cameras were replacing old ones. Chief Dominguez answered.

Alder Furlow asked how many cameras there were, both old and new. Chief Dominguez said she would have to get back with the number of cameras.

Alder Furlow asked if the locations of the old cameras and the new cameras. Chief Dominguez said she would get back with that information.

Alder Marchand asked chief Dominguez to send the presentation to the committee members. She said that she would.

Alder Rodriguez asked about the Community Policing and to improve it with lighting for safety. Chief Dominguez spoke on this.

Alder Hurt asked about the camera situation between New Haven and Bridgeport/Hartford. Chief Dominguez spoke on this. Assistant Chief Jacobson also spoke about this subject.

Alder Decker asked about shot spotter and how it worked. Chief Dominguez spoke on this.

There were no further questions.

Alder Marchand asked if anyone from the public wished to testify. The following came forward.

- a. Chaz Corman-900 Chapel Street- Favor of shot potters & cameras.
- b. Pastor Kelsey Steele-235 Belview Avenue In favor of shot spotters and cameras.
- c. Kim Harrris-29 Lindy Street In favor of shot spotters and cameras.
- d. Ron Huggins-15 Westerly Road In favor of shot spotters and cameras.
- e. Stacey Spell-157 Church Street In favor of shot spotters and cameras.

Alder Marchand asked 3 times if anyone else from the public whished to testify. No one came forward.

4.ORDINANCE AMMENDAMENT PURSUANT TO ARTICLE VIII OF THE CHARTER AND SECTION 2-10 OF THE CODE OF GENERAL ORDINANCES ELIMINATING NEGATIVE LINE BALANCES FOR THE FISCAL YEAR ENDING 6-30-21.

Michael Gormany, Acting City Controller, CAME BEFORE THE COMMITTEE AND SPOKE ON THE TRANSFERS NEEDED TO BALANCE THE BUDGET.

Alder Festa asked if they could have used the Contract Reserves earlier. Mr. Gormany answered this.

Alder festa asked about the internet rates. Mr. Gormany spoke on this and told the committee he would have to get back with the actual rates.

No further questions were asked.

Alder Marchand asked three times if there was anyone from the public who wished to testify. No one came forward.

At 8:40 PM, a motion by Furlow, seconded by Festa, was made to close the public portion of the meeting. The motion was unanimously approved.

Committee Action:

- 1. Alder Festa seconded by Rodriguez, to move item 1 favorably. The committee voted unanimously to approve the reclassification request.
- 2. Alder Festa seconded by Rodriguez, to move items 2 & 3. The committee had a discussion concerning the transfer requests. The committee voted unanimously to approve these transfer requests.
- 3. Alder Festa seconded by Furlow, to move item 4 favorably. The committee voted unanimously to approve the transfers to balance the FY 21 budget.

At 8:55 PM, on a motion by Morrison, seconded by Furlow, the Committee voted to close the meeting.
