1. Levy on any of your taxable goods, or chattels and dispose of them as the law directs notwithstanding the provisions of subsection J of Sec. 52-352b,
2. Enforce by levy and sale any lien upon real estate for said taxes, or levy upon and sell your interest in any real estate as exists at the date of the levy, pursuant to provisions of Sec 12-157,
3. Make demand upon the main office of any banking institution, indebted to such person, subject to the provisions of Sec 52-367a, as amended by section 1 of Public Act 81-352 or section 2 of Public Act 81-352,
4. Garnish wages as if judgment had been entered, in accordance with sections 52-361a.
