Meeting Minutes

Alder C. Rodriguez, Co-Chair called the meeting to order at 6:30 p.m., March 25, 2025, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. C. Rodrigue, Crespo, Douglass, DeCola, Wingate, Miller, Marx, Morant, Redente, and Mabery-Niblack.
