In order to receive Coronavirus State and Local Fiscal Recovery Funds (“SLFRF” or "the Funds") passing through the City of New Haven (the “City”), the Engineering Department (the “Department”) hereby agrees to the following terms, conditions, and obligations.

Section 1. Purpose:

The purpose of the SLFRF is to provide direct payments to eligible entities to:

1. Respond to the public health emergency, COVID-19 or its negative economic impacts, including providing assistance to households, small businesses, nonprofits, and impacted industries, such as tourism, travel, and hospitality;

2. Respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers of eligible employers that have eligible workers who are performing essential work, or by providing grants to eligible entities who perform essential work;
3. Provide government services, to the extent COVID-19 caused a reduction in revenues collected in the most recent full fiscal year of the State, Territory, Tribal government, Metropolitan city, County, or Non-entitlement units of local government; and
4. Make necessary investments in water, sewer, or broadband infrastructure.

Section 2. Compliance:

The City is a primary recipient of SLFRF funds and has the authority to grant sub-awards to eligible subrecipients. The Department will be considered a subrecipient of the City's SLFRF funds and is required to follow all applicable SLFRF rules and regulations.

The Department agrees to have appropriate accounting systems in place to track and report on expenditures reimbursed from the Funds and maintain financial records to support all expenditures submitted. Any allocated costs must be properly supported. Budgeted estimates do not qualify as actual expenditures.

Costs invoiced under this agreement will be supported by documentation maintained by the Department. Documentation will include but is not limited to administrative policies and procedures, internal controls, competitive contracts and purchase orders, equipment inventory, audit reports and findings, and other documentation as identified by relevant Treasury Regulations, FAQs, and Office of Inspector General memoranda.

In order to facilitate SLFRF compliance, the Department agrees to provide all data requested by the City in a prompt and timely manner.

Subaward of Period Performance - Effective date July 1, 2024 to December 31, 2026.

The Department will confirm and ensure that all expenditures of SLFRF funds are eligible under the SLFRF final rule and such additional applicable Terms and Conditions, orders, regulations, rulings, interpretations, and directives for the SLFRF as may be promulgated or issued by the Treasury, as updated from time to time, all of which are incorporated herein by reference. If such eligibility is in any way unclear, the Department will seek and receive prior approval from the City before any funds are spent on potentially ineligible programs or costs.

The City and/or the Department may terminate this Memorandum of Understanding for any reason upon thirty (30) days' written notice to the other party. In the event of such termination, the Department shall be entitled to receive disbursements for Program activities satisfactorily completed prior to the date such termination notice is given.

Program Name: Youth and Community Hubs, a Building Decarbonization Initiative, Public Space and Parks Improvements, the Low/No-Cost Energy Efficiency and Electrification Improvements, a Sidewalks Program, a Storm Infrastructure Improvement Program, and support for the Long Wharf Park Expansion project

Amount: \$14,069,257.25

- **Youth Centers (23143082):** \$2,400,000.00 that will support Youth Centers that will create up to eight Youth and Community Hubs in existing City assets to provide flexible space for youth and community programming, both by the City and external sources; priorities are the West Rock Nature Center, Coogan Pavilion, Barnard Nature Center, Trowbridge Rec Center, East Rock Ranger Station, Goffe St Park Community Building, and the Atwater Senior Center
 - *Balance to Date - \$787,578.92*
- **Building Decarbonization (23143103):** \$1,671,730.00 that will support building decarbonization to be used to develop and implement plans for the decarbonization of City buildings through retrofitting heating, ventilation, and air conditioning systems; projects will focus on the replacement of fossil fuel-fired systems with high efficiency electric alternatives, such as mini-split, multi-split, and variable refrigerant flow heat pumps and energy recovery ventilators; priorities include 200 Orange Street and continuing progress on the electrification of smaller City properties such as libraries, police substations, and fire station living quarters
 - *Balance to Date – \$1,126,300.17*
- **Low/No-Cost Energy Efficiency and Electrification Improvements (23143104):** \$1,600,000.00 that will support the Cost-Free Energy Efficiency and Electrification Improvements Navigators, which includes projects that remediate health hazards that block energy efficiency improvements and to improve energy efficiency in one to four family properties, to support multifamily building electrification, and a Clean Energy Workforce Development
 - *Balance to Date - \$1,600,000*
- **Public Space and Park Improvements (23143107):** \$4,747,527.25 that will support public space and parks improvements, to include capital improvements at parks and public spaces citywide, including public health measures in parks and areas designated for preservation, climate resilient infrastructure and upgrades to outdoor recreation opportunities
 - *Balance to Date – 1,098,768.54*

- **General Storm (23143226):** \$650,000.00 that will support general storm improvements, to include structural maintenance of the City's drainage infrastructure; funding will be used for repairs to the City's drainage system, which includes but is not limited to catch basin repairs,

bioswale repairs and maintenance, manhole adjustments, drainage pipe replacements and outlet controls

- ***Balance to Date - \$228,426.84***
- **Long Wharf Park Expansion (23143227):** \$1,000,000.00 that will support the Long Wharf Park Expansion project, which includes capital improvements to Long Wharf Park, including but not limited to, closure of Long Wharf Drive, construction of structures and amenities for the park, walking/biking infrastructure, play structures, and other improvements for the transformation of Long Wharf Park; the funding will seek to leverage other state and/or federal funding sources
 - ***Balance to Date - \$912,800***

Section 4. Audit

SLFRF payments are considered to be Federal financial assistance subject to the Single Audit Act (31 U.S.C. sec. 7501- 7507).
