Meeting Minuites

Alder Marchand, Chair called the meeting to order at 6:00 p.m., June 12, 2023, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Marchand, Santiago, Douglass, Morrison, Walker-Myers, Furlow, and Singh.

1.
