Meeting Minutes

Alder Crespo called the meeting to order at 9:32 p.m., November 23, 2021 via webinar. Present were Alds. Crespo, Santiago, Douglass. Roth, Ortiz, Edwards, and Singh. Also, in attendance were Alds Festa, Furlow, and C. Rodriguez.

- 1. ORDER CONCERNING REAL PROPERTY TAXES OF WILLIAM JACKSON ON HIS MOTOR VEHICLE TAX ACCOUNT NUMBERS 76454 AND 75158.
- 2. ORDER CONCERNING REAL PROPERTY TAXES OF TAMIKA FLOWERS ON HER MOTOR VEHICLE TAX ACCOUNT NUMBERS 935874, 67320, AND 67778.

Alder Crespo asked if there was anyone present for item 1 and 2. Donald Hayden, Committee staff, told him that they never responded to the notification for the meeting, and this was the third time they had been on the agenda.

3. ORDER ABATING (DEFERRING COLLECTION OF) REAL PROPERTY TAXES DUE FROM HELEN FREEMAN ON HER RESIDENCE GRAND LISTS OF 2017 THROUGH 2020.

Jerry Pagter, legal representative for Mrs. Freeman spoke to the committee concerning the request.

No questions were asked.

4. FROM BEACON COMMUNITIES SERVICES LLC SUBMITTING AN ORDER CONCERNING AN APPLICATION FOR TAX ABATEMENT FOR THE MIXED INCOME, MIXED USE AFFORDABLE DEVELOPMENT PROPOSED AT STATE & CHAPEL STREET IN NEW HAVEN, CONNECTICUT.

Dara Kovel, Leann Hanfield, and Ben Phillips, from Beacon Communities, and Michael Piscitelli, Economic Development Administrator came before the committee. Ms. Kovel spoke to the committee about the requested tax abatement followed by Ms. Hanfield.

Alder Santiago asked if there was a 3% annual increase to the payments. Ms. Kovel said there was.

Alder Roth asked if they were getting \$2.5 million dollars from the city. Ms. Kovel said that they had applied to the state for this money.

Alder Roth asked if they were going to accept Sec 8 funded people. Ms. Kovel said that they were not.

No further questions were asked.

Alder Crespo asked three times if there was anyone from the public who wished to testify. No one came forward.

5. FROM CLARUS GLOBAL ALLIANCE SUBMITTING ON BEHALF OF COMMUNITY PRESERVATION PARTNERS DBA FAIRBANKS COMMUNITY PARTNERS LP AN APPLICATION FOR A TAX AGREEMENT REGARDING ITS 100% AFFORDABLE HOUSING REHABILITATION AT 355 FERRY STREET.

Barry Cunningham (Consultant), Seth Gilles and John Frasier, from Fairbanks Community Partners, came before the committee. They each took a turn speaking to the committee about the project.

Alder Roth asked if they could raise the rent by taking Sec 8 funded families. Mr. Frasier answered the question.

No further questions were asked.

Alder Crespo asked three times if there was anyone from the public who wished to testify. No one came forward.

Alder Crespo told the committee that items 6, 7, and 8 were for committee action only because these were repeat request for tax abatements and they still met the requirements.

At 11:06, a motion by Santiago, seconded by Edwards, was made to close the public portion of the meeting. The motion was unanimously approved.

- 3. Alder Santiago seconded by Roth, made a motion to move item 4 favorable, pending additional information coming before the Board of Alders votes on it. The committee, by voice vote, to approve the tax abatement request from Beacon Communities.
- 4. Alder Santiago seconded by Douglass, made a motion to move item 5 favorably. The committee, by voice vote, to approve the tax abatement request from Fairbanks Community Partners.
- 5. Alder Santiago seconded by Douglass, made a motion to move items 6, 7, and 8 favorably. The committee, by voice vote, to approve the tax abatement request for Mrs. Nelson, Mrs. Sockwell and Ms. Dorsey.

At 11:34 PM, on a motion by Santiago, seconded by Douglass, the Committee voted to close the meeting.
