6. Alder Wingate, seconded by Streeter, made a motion to move item 6 to forgive the taxes, fees, and interest on Ms. Saldana's tax accounts. The committee voted by voice vote, to approve this action

At 7:20 PM, on a motion by Wingate, seconded by Miller, the Committee voted to close the meeting.
