Meeting Minutes

Alder Santiago called the meeting to order at 5: p.m., November 27, 2018 in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Santiago, DeCola, Antunes, Douglas, Ortiz, and Winters.

1. ORDER CONCERNING REAL PROPERTY TAXES OF SAINT MARY'S BAPTIST UNISON BAPTIST CHURCH, LOCATED AT 24 KOSSUTH STREET, TAX ACCOUNT NUMBER 19225.

May Bay-Reed came before the committee and spoke concerning the request of the church. A discussion was had concerning the churches nontaxable status and the legal fees incurred by the foreclosure action taken by the City.

No other questions were asked by the committee.

2. ORDER ABATING (DEFERRING COLLECTION OF) REAL PROPERTY TAXES DUE FROM YOUSUFU AND MIKIRI SHERIFF ON THEIR RESIDENCE KNOWN AS 25 STEVENS STREET, GRAND LISTS OF 2015, 2016, AND 2017

Mister Sheriff came forward and explained his request for a tax abatement on his home.

Mr. Jones came before the committee to explain his request. He gave the committee a copy of a Car Fax report for the Mercedes showing how long he owned this car.

A discussion concerning what Mr. Jones could afford to pay, with the reduction of interest and the taxes on the Mercedes. Mr. Jones said that he could pay \$2,000.

Committee Action:

1. Alder Winters, seconded by DeCola, made a motion to move item 17 to approve the tax abatement request from Mrs. Consiglio. Adler DeCola told the committee that she had gotten a tax abatement before and still met the requirements. The committee voted, by voice vote, to approve the motion.

2. Alder DeCola, seconded by Douglass made a motion to move item 18concerning the vehicle taxes owed by Mr. Rayas. Alder Santiago told the committee that Mr. Rayas was willing to pay \$700, which was the taxes and part of the past interest. The committee voted, by voice vote, to approve the motion.

3. Alder DeCola, seconded by Antunes, made a motion to move item 1 and forgive the tax and interest owed by Saint Mary's Unison Baptist Church and to refund taxes already paid, less the legal cost that the City incurred. The committee voted, by voice vote, to approve the motion.

4. Alder DeCola, seconded by Douglass, to move item 2 to approve the tax abatement for Mr. & Mrs. Shariff. The committee voted by voice vote to approve this motion.

5. Alder DeCola seconded by Douglass, made a motion to grant item 3, City Lights Auto Sales and item 11 Catherine Bonnell, Leave to Withdraw. The committee voted, by voice vote, to approve this motion.

6. Alder DeCola, seconded by Douglass, made a motion to move item 6, and to forgive the interest owed by Ms. Rodriguez. The committee voted, by voice vote, to approve the motion.

7. Alder DeCola, seconded by Douglass, made a motion to move item 7, and to reduce the taxes and interest owed by Mr. Jones to \$2,000. The committee voted, by voice vote, to approve the motion.

8. Alder DeCola, seconded by Douglass, made a motion to move item 10 and forgive the tax and interest owed by Mrs. Woodhouse and to have it as a Unanimous Consent item at the next Board of Alders meeting. The committee voted, by voice vote, to approve the motion.

9. Alder DeCola, seconded by Antunes, to move item 12 to give the request from Mr. Kaya Leave to withdraw because they felt that they could afford the taxes. The committee voted, by voice vote, to approve the motion.

10. Alder DeCola, seconded by Douglass, made a motion to move item 14 and forgive the interest owed by Ms. Floyd. The committee voted, by voice vote, to approve the motion.

11. Alder DeCola, seconded by Winters, made a motion to move item 15 and forgive the

interest owed by Mr. Alvarado and to have it as a Unanimous Consent item at the next Board of Alders meeting. The committee voted, by voice vote, to approve the motion. 12. Alder DeCola, seconded by Winters, made a motion to move item 16 from Mr. Wentworth and give it Leave to. The committee voted, by voice vote, to approve the motion.

At 7:25 PM, on a motion by DeCola, seconded by Antunes, to close the meeting. The committee voted to close the meeting.
