## Meeting Minutes

*Alder Hurt, Committee Vice-Chair called the meeting to order at 6:05 p.m., May 11, 2023, in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Aids. Marchand, Hurt, Santiago, Douglass, DeCola, Morrison, Hamilton, Festa, Furlow, and Singh.*

### *Committee Action:*

*1. Alder Marchand, seconded by DeCola, moved items number 11 through 14, the four Special Service District 2023-24 budgets. The committee voted unanimously, by voice vote, to approve this motion.*

*2. Alder Marchand, seconded by DeCola, moved items 7 through 10, the four Enterprise Fund 2023-24 budgets. The committee voted unanimously, by voice vote, to approve this motion.*

*3. Alder Marchand, seconded by DeCola, moved items number 1 and 2, Appropriating Ordinance #1 and #2, for discussion.*

*a. Alder Marchand, seconded by DeCola made a motion to approve the Technical Amendments, which he read to the committee. The committee had a discussion concerning the Technical Amendments. The committee voted by voice vote, Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Santiago, Douglass, Singh, voted in Aye, and Alder Festa voted Nay. The vote was 9 Aye and 1 Nay, the technical amendments were approved.*

*b. Alder Marchand, seconded by Morrison made a motion to approve Amendments, which he read to the committee. The committee had a discussion concerning the proposed Amendments. The committee voted by voice vote, Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Santiago, Douglass, Singh, voted in Aye, and Alder Festa voted Nay. The vote was 9 Aye and 1 Nay, the amendments were approved.*

*c. Alder Festa, seconded by Singh, made a motion to approve proposed amendments, which she went over for the committee. The committee had a discussion concerning these amendments. Alder Marchand asked Alder Festa to withdraw her requested amendments, which she did.*

*d. Alder DeCola, seconded by Marchand, made a motion for an amendment to transfer \$50,000 from Central Services Other Contractual to CAPA. The committee voted unanimously to approve this amendment.*

*e. Alder Festa, seconded by Singh, to amend Ordinance #1 by removing a park Ranger from the Department of Youth & Recreation and adding a Caretaker I position to Parks & Public Works and an Active Transportation Planner to the department of Transportation, Traffic and Parking, and to increase the ARPA funding by \$89,347.*

*The committee had a discussion concerning this amendment request and voted, by voice vote, Alder Santiago and Festa voted Aye, Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Douglass, Singh, voted in Nay. The vote was 2 Aye and 8 Nay, the*

*amendment was not approved.*

*f. Alder Festa, seconded by Singh, made a policy amendment to Appropriating Ordinance #1, concerning opening up City Hall by having city employees return to work in city hall.*

*The committee had a discussion concerning this amendment and Alders Marchand, Morrison, Furlow, and Douglass spoke against it.*

*Alder Marchand asked Alder Festa to withdraw her amendment request and said that as Chair of the Finance Committee, he would schedule a workshop concerning her request. Alder Festa withdrew her amendment request.*

*Alder Marchand, seconded by DeCola, moved item 1 and 2, as amended. The committee voted by voice vote, Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Santiago, Douglass, Singh, voted in Aye, and Alder Festa voted Nay. The vote was 9 Aye and 1 Nay, Ordinance Amendment #1, and Ordinance Amendment #2, as amended, were approved.*

*4. Alder Marchand, seconded by DeCola, moved item number 3, Appropriating Ordinance #3 authorizing issuance of General Obligation Bonds for fiscal year 2024, and item number 6, Reallocating 6.3 Million dollars of ARPA funds, for discussion.*

*Alder Festa, seconded by Singh, made a motion to amended Appropriating Ordinance #3, by changing the language in Section VI: Refunding Bonds.*

*The committee had a discussion concerning this amendment request. The committee voted, by voice vote, with Alder Festa and Singh voting Aye, and Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Douglass, Santiago, voted Nay. The vote was 2 Aye and 8 Nay, the amendment was not approved.*

*Alder Marchand, seconded by DeCola, moved item 3 and 6. The committee voted by voice vote, Alders Furlow, Morrison, Hamilton, DeCola, Marchand, Hurt, Santiago, Douglass, Singh, voted in Aye, and Alder Festa voted Nay. The vote was 9 Aye and 1 Nay, Ordinance Amendment #3, and item number 6, Reallocating 6.3 million dollars of ARPA funds, were approved.*

*5. Alder Marchand, seconded by DeCola, moved item number 4, Appropriating #4 General Obligation Tax Anticipation Notes and/or General Obligation Grant Anticipation Notes for Fiscal Year 2024.*

*The committee voted unanimously, by voice vote, to approve Appropriating Ordinance #4.*

*5. Alder Marchand, seconded by DeCola, moved item number 5, Ordinance Amendment section 17-201 of the General Code of Ordinances Authorizing Additions and changes in Permits, Licenses and User Fees for the fiscal year 2023-2024, for discussion.*

*Alder Marchand, seconded by DeCola made a motion to approve the Technical Amendments, which he read to the committee. The committee had a discussion concerning the Technical Amendments and. voted by voice vote, to approve the technical amendments.*

*Alder Marchand, seconded by DeCola, moved item 5, as amended. The committee voted by voice vote, to approve the amended Ordinance Amendment section 17-201 of the General Code of Ordinances Authorizing Additions and changes in Permits, Licenses*

*and User Fees for the fiscal year 2023-2024.*
