Meeting Minutes

*Alder Marchand, Chair called the meeting to order at 6:00 p.m., November 10, 2025, in*

*the Aldermanic Chamber, 165 Church Street, New Haven. Present were Aids. Marchand, DeCola, Morrison, Walker-Myers, Hamilton, Festa, H. Smith, and Punzo.*

*ORDER OF THE BOARD OF ALDERS OF THE CITY OF NEW HAVEN

*Dr. Christy Sampieri, Controller, came before the committee and spoke on the request.*

*Alder Punzo asked what was different with using this program. Dr. Sampieri explained.*

*Alder Punzo asked if the new process would eliminate positions. Dr. Sampieri explained.*

*Alder Festa asked how people who worked remotely would clock in/out. Dr. Sampieri explained how this would happen.*

*Alder Marchand asked when it would start. Dr. Sampieri said in April 2026.*

*Alder Marchand asked what the savings would be in the cost of the Munis program without this function. Dr. Sampieri explained.*

*Alder Festa asked when the Munis contract would end. Dr. Sampieri did not know the exact date.*

*No further questions were asked.*

*Alder Marchand asked three times if anyone from the public wished to testify. No one came forward.*
