Adler DeCola told the committee that they had gotten a tax abatement before and still met the requirements. The committee voted, by voice vote, to approve the motion.
- 2. Alder DeCola, seconded by Douglas made a motion to move item 4 concerning the tax abatement for Mrs. Tate. The committee voted, by voice vote, to approve the motion.
- 3. Alder DeCola, seconded by Antunes, made a motion to move item 5 and forgive the tax increase for Mr. Moore, due to the error made by the Assessor's office. The committee voted, by voice vote, to approve the motion.
- 4. Alder DeCola, seconded by Douglas, to move item 8, 10, 12, and 14 for Leave to Withdraw, requests from Ms. Jackson, Mrs. Stewart, Ms. Cornigans and Mr. Rayas. The committee voted by voice vote to approve this motion.
- 5. Alder DeCola seconded by Douglas, made a motion to move item 9, to forgive the interest and reduce the taxes to \$868.54 for Ms. Elliott. The committee voted, by voice vote, to approve this motion.
- 6. Alder DeCola, seconded by Douglass, made a motion to move item 11, and to refund the \$206.95 Mr. Griffin had to pay to get her car released from the tow yard. The committee voted, by voice vote, to approve the motion.
- 7. Alder DeCola, seconded by Douglas, made a motion to move item 13, and to forgive the interest owed by Mr. Bakr and to send for Unanimous Consent at the next Board of Alders meeting. The committee voted, by voice vote, to approve the motion.

At 8:30 PM, on a motion by DeCola, seconded by Antunes, to close the meeting. The committee voted to close the meeting.
