Minutes

Alder Ellen Cupo, Chair, called the public hearing to order at 6:02 p.m.

Present were Alders Ellen Cupo, Chair; Richard Furlow, Vice-Chair; Rosa Santana; Jeanette L. Morrison; Adam J. Marchand; E. Rodriguez, and Eli Sabin.

1. ORDER OF THE NEW HAVEN BOARD OF ALDERS REGARDING AMENDMENTS TO THE CODE OF GENERAL ORDINANCES, SECTION 7 (ANIMALS): REGARDING POTENTIALLY DANGEROUS, DANGEROUS, AND/OR VICIOUS DOGS, BREEDERS' PERMITS, PARVOVIRUS VACCINATIONS, AND DOG LEASHES.

PUBLIC TESTIMONY

Stacey Ober, J.D., AKC Government Relations Regional Manager for New England, Massachusetts, presented the changes in the original submission as well as the amended submission that includes recent changes in state law.

Earle Giovanniello, Assistant Corporation Counsel, 600 Hawkins Road, Orange, spoke in favor of the changes submitted by Stacey Ober on behalf AKC.

In response to Alder Furlow, Attorney Ober reviewed how other states and towns have implemented changes including requiring shelters to microchip animals adopted from the shelter. Discussed cultural differences in dog breeding and allowing dogs to roam.

In response to Alder Marchand, Attorney Ober reviewed how this ordinance affects people who are breeding dogs as a hobby versus people who are breeding professionally. Reviewed how breeder permits typically cost more to implement than enforcement warrants.

In response to Alder Sabin, Attorney Ober discussed how they do caution against creating burdensome ordinances as people who follow the rules will dot their "I's" and cross their "T's," but others will not comply. Reviewed how fixing dogs early before adolescence can cause health issues including cancer and arthritis, so more people are waiting to spay or neuter their dogs. Discussed how if the city's ordinance uses different terminology than the state statute, it risks being vague and conflicting with state law.

Assistant Corporation Counsel Giovanniello reviewed how the ordinance does need to be amended to comply with the state statute, as the statute referenced has been appealed and is no longer applicable. Confirmed needs to comply with state statute.

In response to Alder E. Rodriguez, Attorney Ober reviewed how she believes the drafters copied language from state statutes regarding the definition of animals.
