My life was exactly as I had envisioned it, it was cut short by COVID. Knowing that I did have a certain level of security, I returned to New Haven anxious to renew my interests in both food and growing.

I was introduced to Doreen Abubakar and volunteered with her in her Urbanscapes Native Plant Nursery in Newhallville. Additionally, she enabled me to participate in the UConn Urban Farming Training Program. During that time, I received a flyer invitation to join an effort to develop food and growing policies in New Haven, and in September of that year, I became a member of the Urban Agriculture Master Plan Community Advisory Board.

The next two years I engaged in community with the purpose of developing laws to enhance the experience of growers and communities in New Haven. Since then, I have graduated from the UConn Master Gardener Program and continue to expand my knowledge on farming through the Cornell Small Farms Program.
