I am interested in serving on the Youth Commission because I am deeply committed to empowering young people and amplifying their voices through community-driven initiatives and restorative practices. Over the past seven years, my work in youth development has focused on creating safe spaces for self-expression, leadership, and personal growth. I am passionate about addressing the barriers that many young people face—whether social, economic, or educational and ensuring they have access to the resources and support needed to thrive. Serving on the Youth Commission would allow me to advocate for policies and programs that prioritize youth empowerment, equitable opportunities, and community engagement.

Why do you believe you would be a good fit for your selected board and commission(s)?

I believe I would be an exceptional fit for the Youth Commission because of my extensive background in youth development, community engagement, and restorative practices. For over seven years, I have dedicated my career to empowering young people through storytelling, arts education, and experiential learning. As a teaching artist, I have led creative writing and storytelling workshops at Common Ground High School, Highville Charter Upper School and Trinity Liberal Arts College International Hip Hop Festival's Youth 4 Change initiative (amongst others), centering self-expression and community-building. My work as an experiential facilitator has included guiding youth through team-building exercises, environmental education and leadership training, equipping them with the confidence and skills to thrive. Additionally, my training in nonviolent communication and restorative practices have been integrated into my work as a consultant and facilitator. have provided training for Youth at Work interns placed with Solar Youth, delivered facilitations for The CT Justice Alliance (formerly the CT Juvenile Justice Alliance), and supported staff and clinicians at Highville Charter School and Integrated Wellness Group with trauma-informed and culturally responsive approaches. My commitment to youth advocacy extends to my role as a mentor with CHOICES, an at-risk youth violence intervention program, where I work directly with high school athletes navigating complex life challenges. I also recently became an emergency foster placement and am in the process of becoming a licensed foster parent, further deepening my understanding of the critical needs of vulnerable youth. My hands-on experience with community-based programs and my dedication to creating equitable opportunities for youth would allow me to bring valuable insights to the Youth Commission, supporting its mission to enhance the lives and futures of young people in New Haven.
