ORDER OF THE NEW HAVEN BOARD OF ALDERS AUTHORIZING
THE BOARD OF EDUCATION'S EXECUTION OF THE AGREEMENT
WITH SEVERIN INTERMEDIATE HOLDINGS LLC TO PROVIDE
POWERSCHOOL STUDENT INFORMATION SYSTEM SOFTWARE
AND SUBSCRIPTION LICENSE FOR PERFORM TEACHER
EVALUATIONS, ENROLLMENT REGISTRATION, ECOLLECT
FORMS, SIS HOSTING (CLOUD) MAINTENANCE AND SUPPORT
FROM JULY 1 2025 TO JUNE 30, 2030 IN AN AMOUNT NOT TO
EXCEED \$1,720,537.81.

WHEREAS, the New Haven Board of Education (the "Board") and Board of Education, Severin Intermediate Holdings, LLC. (the "Vendor") are the parties (collectively the "Parties"); and,

WHEREAS, the Parties reached an agreement for PowerSchool Student information system software and subscription license for perform teacher evaluations, enrollment registration, e-collect forms, SIS Hosting (cloud) maintenance and support with Severin Intermediate Holdings, from July 1, 2025 to June 30, 2030 (the "Agreement"); and,

WHEREAS, the district staff submitted the Agreement with Severin Intermediate Holdings, LLC for services outlined to the Board, which was approved at its June 23, 2025 Board of Education meeting; and,

WHEREAS, the Charter of the City of New Haven requires the approval of the Board of Alders for multi-year professional services agreements.

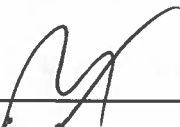

Agreement as well as such additional instruments as may be deemed necessary or expedient to implement the terms of the agreement.

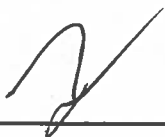

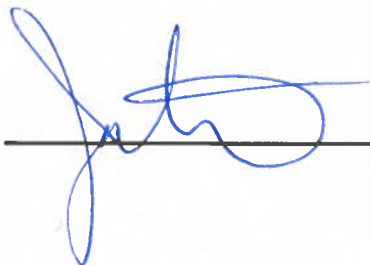
