ORDINANCE AMENDMENT TO APPROPRIATING ORDINANCE # 1AUTHORIZING BUDGET TRANSFER #201-15-1 TRANSFERRING FUNDS FROM THE POLICE SEQUESTRATION ACCOUNT IN THE AMOUNT OF \$1,000,000 TO THE POLICE DEPARTMENT OVERTIME ACCOUNT PLUS AN ADDITIONAL OVERTIME TRANSFER OF \$281,000 TO COVER THE OVERTIME EXPENSES ASSOCIATED WITH THE SUMMER ANTI VIOLENCE INITIATIVE (S.A.V.I.) FROM A PROJECTED SURPLUS IN THE WROKERS COMEPENSATION LINE ITEM

WHEREAS, Section 60 of the Charter and Section 2-386(3) of the Code of General Ordinances requires the approval of the Board of Aldermen for the transfer of funds within the General Fund budget; and,

WHEREAS, funds in the Police Department operational overtime account are projected to run out in the beginning of the third quarter of FY 2015-2016; and,

WHEREAS, the Police Department received administration and leadership approval to embark on a Summer Anti Violence Initiative (S.A.V.I.) which incurred overtime expenses of \$281,000 that were not contained within the Police Department FY 14-15 budget, and

WHEREAS, there is currently a projected surplus in the Workers Compensation lien item,

NOW, THEREFORE, BE IT ORDAINED by the New Haven Board of Aldermen that Transfer #201-15-1 be approved to transfer \$1,000,000 from 1-201-2040-50177 (Police Sequestration) to 1-204-1010-50130 overtime for additional funds needed for overtime based on current projections and \$281,000 from 1-805-9530-59933 to 1-201-2040-50130 for overtime incurred during the implementation of the Summer Anti Violence Initiative.
