Alice Forrester, PhD, is the Executive Director of the Clifford Beers Clinic in New Haven, CT. Clifford Beers Clinic is a \$16 Million, 200 Staff, 104 year old community based, mental health center for excellence for the treatment of children and families. CBC is a recent recipient of a 2014 Center for Medicaid and Medicare Services Healthcare Innovation Award for a new model of care called "Wrap Around New Haven" for chronically stressed families and children living with chronic health and mental health issues. CBC has been the clinical recovery response for the Sandy Hook Shootings on 12/14/12. She was on the Board of Directors of the Connecticut Community Providers Association, and is Past-President of National Association for Drama Therapy (NADT) and Past Chair of the National Coalition for Creative Arts Therapy Associations (NCCATA). She has served as the Principal Investigator of two National Child Traumatic Stress Network grants, as well as participating as Guide Team Member in the New Haven CT MOMS Project, Funded by HHS Office of Women's Health, at Yale University. She was appointed by the Governor of CT to sit on the Sandy Hook Commission and also sits on the Legislative appointed Children's Mental Health Task Force, and Urban Violence Commission chaired by CT Lt. Governor Nancy Wyman.
