For the past month, I have been canvassing, tabling, and phone banking community members in an effort to hear their healthcare stories. In my conversations, experiences with the healthcare system, degree of insurance coverage, and access to healthcare have varied.

## But what has been consistent across my discussions is the overwhelming and resounding support for Medicare for All in New Haven.

What I love most about New Haven is the kindness and compassion of the residents. From the conversations I've had about Medicare for All, that compassion is apparent; residents want access to quality healthcare and they want the same for their neighbors.

While canvassing, I spoke with a very kind man who had been injured in his workplace in New Haven, causing him to be disabled and unable to work full time. Due to his immigration status, he was unable to receive compensation for the work injury, and despite the accident occurring over ten years ago, he is still suffering financially from the cost of healthcare.

In 2015, it was estimated that more than 14,430 residents in the city were undocumented. ${ }^{1}$ We need a healthcare system that will support all of New Haven's residents, especially undocumented folks. House Bill HR1976 would convert our current for-profit healthcare system into a single-payer model that will cover all American residents, regardless of immigration status, for all healthcare needs.

Additionally, it will save New Haven money (upwards of $\$ 70$ million per year), and protect its residents' from unreasonable costs for care. Another woman I spoke with was visiting family in a neighboring state when she became very sick. In an effort to protect those around her and get adequate treatment, she took a COVID-19 test at a nearby testing center, which came back as positive. She was billed over $\$ 300$ because the test was taken out of state; but If she had not taken the test, she would've put her family at risk by not warning them of their exposure, and if she had traveled back to Connecticut, she would have been forced to come in contact with other residents while infected with COVID-19.

Residents of New Haven should not have to choose between protecting themselves, their families, and their neighbors lives, and paying unreasonable fees for basic care.

Your "Yes" vote to approve an aldermanic resolution in support of the Medicare for All Act of 2021 (H.R. 1976) can be a revolutionary first step to changing this. Please join me and my neighbors in supporting this resolution, and let residents know that you are listening to their stories and taking action.

Dear State Representative, My name is Ashley Makar, and I work in New Haven, where I used to be a resident. (I now live in Hamden.) I'm writing to you now to discuss proposed Senate Bill 1090, An act establishing a commission to study a HUSKY for All, single payer, universal health care program in Connecticut. It is imperative the Committee on Human Services vote this Senate Bill out of committee "Joint Favorable" so the bill can progress to the next stages of the legislative process. Access to affordable healthcare is quite literally a matter of life and death in this world of COVID. Our fellow neighbors, your constituents, are being crippled by premiums, deductibles, and co-pays, if they have access to healthcare through their employment, and even still face medical bankruptcy at too high a rate ( $2 / 3$ of all bankruptcies are due to medical debt). As the pandemic lockdown has meant tens of thousands have lost their jobs, and therefore their employer-sponsored healthcare, we are at risk of our neighbors falling into medical poverty.

I have seen the devastating effects of the lack of access to affordable healthcare among the immigrant communities I work with through IRIS--Integrated Refugee \& Immigrant Services, in New Haven. Also as a cancer patient at Smilow/Yale-New Haven Hospital, I also have experienced the personal risk of prohibitive healthcare costs. Here is a bit of my personal story: When I was diagnosed with stage-4 cancer, I was a New Haven resident who would lose my health insurance in a matter of months. It was January 2011, and I was in the last semester of a graduate program at Yale Divinity School. I was on the student health plan, but I would lose that coverage if I graduated on time the following May. Even though the Affordable Care Act had been passed, there were no affordable options on the healthcare exchange that would not have me paying prohibitive amounts out of pocket (in co-insurance \& co-pays) for CAT scans, chemo treatments, and consultations with oncologists. I decided to delay my graduation, so that I could stay on the Yale Health plan while undergoing cancer treatment. Thanks to the generous attention of administrators at Yale Divinity School, I was allowed to become a part-time student and extend my degree program for a year.

During that year-long grace period, while undergoing chemotherapy, friends who are public health policy experts, did extensive research to see what my options would be once I graduated. Again, there were no remotely affordable options. We determined that my best option would be to apply for disability, so that I could go on Medicare. Given my dire prognosis and the debilitating nature of my cancer treatment, I was granted disability and able to go on Medicare at the age of 35 . Since graduating, l've been able to work part-time and receive the medical care I need. Thanks to my oncology team at Smilow, I was enrolled in a clinical trial in immunotherapy, which has given me a medical miracle: I am now in remission. Medicare has given me a grace period of coverage until

2025, during which time I, once again, will need to navigate my options--comparing the healthcare exchange with employer-based insurance, all of which involve significant co-insurance \& co-pays, which could be prohibitive if my cancer were to recur and necessitate treatment again, not to mention my CAT scans and oncology check-ins every three months. I am very lucky to have Medicare at my age, and I hope every New Haven resident will have the opportunity to access the healthcare they need.

Because of COVID-19, voting "Joint Favorable" on the Senate Bill 1090, an act establishing a commission to study a HUSKY for All, single payer, universal health care program in Connecticut is even more important. Without universal coverage, we are all at risk of the virus spreading as those who are sick or infected may not be able to afford or seek treatment. I understand that it may not be a moral issue for some, however fiscally it is the right thing to do. If we were to implement a taxation process for people and employers to pay into just as they would for the current for-profit commercial insurance plans it would save the State of Connecticut approximately 2.9\% Net Savings. That would be $\$ 1.475$ Billion according to Professor Rodberg, using the renowned Professor Friedberg's formula for determining economic impact. I am asking you to support this Study Bill (SB 1090) and for you to vote "Joint Favorable" in committee. Thank you for taking the time to read this email. I am a resident of New Haven living in Ward 10, and I am writing to ask for your "Yes" vote to approve an aldermanic resolution in support of the Medicare for All Act of 2021 (H.R. 1976), a landmark piece of legislation that would establish a single-payer health program in the United States.

I have now been without any health insurance at all for more than 18 months-during a global pandemic. In the last five years, I have had health insurance from my former employer, from the private market in Connecticut, and from my wife's former employer. However, when her employer's plan changed in December 2019, I was dropped from coverage, and had no opportunity to purchase new insurance until the special enrollment period opened at the beginning of the COVID-19 pandemic. However, because I had been without health insurance for longer than the 60 day window covered by the special enrollment period, I was ineligible to enroll for insurance. I spent scores and scores of hours on the phone with various people working for AccessHealthCT and ConnectiCare, but there were always small exceptions making me ineligible for any plans they offered.

Because I do not have insurance, I avoid regular medical checkups or medical treatment for any issues that might come up; in a pandemic, that makes me a risk not only to myself, but to public health more generally. This has been particularly damaging due to my inability to access mental health services with health insurance, as I've struggled with anxiety and depression due to the pandemic and unemployment. I did have mental health services covered through my previous employer, and the loss of these literally lifesaving services at the same time as I lost my job very concretely illustrates the systemic cruelty of tying health insurance to employers. Our current health care model systematically denies health insurance coverage to people in times of their greatest need.

Even when I was able to purchase insurance through ConnectiCare in 2016, the deductible was so high that it made the insurance totally useless to my family for anything other than a major unexpected catastrophe. Again, this meant we have avoided regular checkups and care that could help prevent more serious illness from developing and therefore lower costs for both us and the insurer. While the Affordable Care Act is certainly better than no system at all due to this ability to address catastrophic instances, we truly need a single-payer system through which everyone is automatically covered and can get the treatment we need before minor health risks become life-threatening.

Every person in New Haven-and in the United States-deserves quality health care, regardless of the marketability of their skills, hobbies, or talents. Currently, far too many of us are uninsured and underinsured, and struggling with medical debt. Under a single-payer system, every single person in New Haven would have health insurance with no premiums, no copays, and no deductibles. We wouldn't have to spend hours and hours "shopping" for insurance. We wouldn't be denied coverage due to eligibility qualifications for enrollment. We wouldn't have to put off care, or live our lives in fear of getting an injury or illness that we couldn't pay for. Additionally, the City of New Haven could save upwards of $\$ 70$ million per year.

By voting "Yes" on this upcoming resolution, you will send a strong message to Hartford and Washington, D.C. that New Haven wants--and urgently needs--Medicare for All.

In any basic economics class, students are taught about market failures that get in the way of a free market and our healthcare system is riddled with them. A major one is the "inelasticity of demand" for health care -- people who need emergency care have no choice but to "buy" their health care. The option not to buy a service or good is critical for a free market. The only type of health care that people can opt not to "buy" is preventive care, but that choice is bad for them, bad for society (think: infectious diseases), and may lead to more emergency care use where again, they don't have the option not to buy.

Another major market failure is the lack of symmetric information about the service or goods offered between those "selling" and those "buying." The false solution of public reporting options about hospital and provider quality and cost are far too complicated and too prone to corruption, cherry picking and manipulation. Thus, they are very unlikely to help individual consumers make choices about reducing the cost of care, thus placing control in the hands of for-profit insurers.

As a result of these and other market failures, any "public option" approach for insurance will inevitably fail to contain costs because commercial insurers will always have a profit motive to cherry pick the lowest risk patients, leaving the sickest and most costly patients in the public option risk pool. The amount of regulation and oversight that would be necessary to ensure that commercial insurers do not cherry pick does not make sense because the administrative costs of the oversight would diminish the benefits and would divert funds from care delivery toward overhead.

We already know this -- this is why Medicaid doesn't work as well as Medicare -- because the risk pool of Medicaid includes the sickest and the poorest while the risk pool of Medicare includes a larger swatch of Americans. Including younger, healthier, lower-risk Americans in the Medicare risk pool will make it work even better!

Finally, it is critical to remember that in the U.S., we already have universal medical care for all but it is for the sickest of the sick -- those who come to the emergency room with life threatening conditions and newborns born prematurely, for example. We universally take care of patients after the heart attack but not when they have high blood pressure... or we take care of the premature infant in our costly neonatal ICUs but not the young woman thinking about getting pregnant. This type of care is the most costly, least equitable, and least humane approach -- it is frankly a national shame given our nation's promise to ensure "life, liberty, and the pursuit of happiness." By having a universal SICK care system instead of universal HEALTH care system we are shooting ourselves in the foot as a nation -- paying more for worse health and quality of life. Furthermore, we are perpetuating systemic racism by disproportionately burdening black and brown populations with the lack of insurance, underinsurance, lack of preventative care, and crippling medical debt.

Under a single-payer system, the City of New Haven could save millions per year, and our communities, and the nation as a whole, can begin to undo the damage that has been done by our current unethical, illogical payment systems.

By voting Yes on this upcoming City Council resolution, you will send a strong message to Hartford and Washington, D.C. that New Haven wants Medicare For All.

Finding reputable care was put up against the clock of his willingness to get help, it's an extremely stressful situation for a family to be in. Along with that, there were unattended issues of depression that may have been a factor in his use in the first place.

But more than anything, what l've learned from him is that he was intolerant to the privilege his white skin carried in navigating all the issues related to the war on drugs. When are we going to stop being grateful our children are white? That's the gross outcome of our systems as they are. Our young people see clearly that they do not want us to carry forward the harms of our racist policies. They have asked us to stop, and I think it's time we listen. Medicare for all brings relief when families need it most.

Since 2016, when my own son checked himself into care, the overdose rates have increased by $41.3 \%$. Those aren't numbers, those are families. We have to work to change systems so that more people have access to the care they need without losing their homes, jobs, livelihoods. Addiction does enough damage to a family on its own. We need systems that work for families. Please support Medicare for All.
