Co-Chairs Kimberly Edwards and Jody Ortiz called the public hearing to order at 6:03 p.m. in the Alder Chamber.

Also present were Alders Wingate, Sabin, Acosta, C. Rodriguez, and H. Smith.

FIRST AND ONLY HEARD WAS: From the Deputy Community Services Administrator submitting a Resolution of the New Haven Board of Alders Authorizing the acceptance of a Connecticut Department of Education grant for \$125,000 to provide a pilot program for after-school skilled vocational and credentialed training to high school students with Justice Education Center of 62 Lasalle Rd #308 West Hartford CT acting as the sole source to administer the Career Pathways Eli Whitney Afterschool Program.

Appearing on behalf was Gwendolyn Busch Williams, business manager of the city's Youth department. She distributed written materials. She gave a brief summary of the Career Pathways Technology Collaborative. It is an after-school program at the Eli Whitney regional trade school in Hamden. There is also a summer session. The program focuses on young people who are not bound for college. They learn trades like carpentry and plumbing. The program has improved their literacy and math schools. The students are recruited from city high schools as well the Youth Stat program.

In response to Alder Wingate, Williams said they have a successful job placement program.

The committee voted to close public testimony at 6:16 p.m.
