Meeting Minutes Community Development Committee

Chair Wingate called the public hearing to order at 6:09 p.m. via video conference. A recording of the meeting is online at https://bit.ly/3pbojweL

Present were Alders Douglass, Marks, DeCola, Cupo, Marks, and C. Rodriguez. Non-committee-member Alders present were Walker-Myers, Furlow, Morrison, Winter, and Antunes.

Board of Alders staff present were Albert Lucas and Michael Mercier.

The chair discussed rule for the meeting, such as a three-minute speaking limit for public commenters.

First and only heard was: From the Acting Director of The Livable City Initiative submitting an Order of The New Haven Board Of Alders approving the Development and Land Disposition Agreement between the City of New Haven and Conncorp, LLC for the conveyance of real property known as portions of Dixwell Plaza, New Haven, Connecticut.

Appearing on behalf were: city officials Michael Piscitelli, Economic Development Administrator; Arlevia Samuels, Interim LCI Director; and attorneys John Ward and Michael Pinto.

Representatives of ConnCORP/ConnCAT included: Erik Clemons, Hard Street; Carlton Highsmith, Middlebury; Paul McCraven, address inaudible; and Yves Joseph of R.J. Development, Long Wharf.

They described the proposal for the project which will create a new development at the site of the Dixwell Plaza shopping center. Features will include a day care, grocer, vocational training, and a food hall. It will include affordable housing, with opportunities for homeownership, jobs, and education, along with a positive economic impact on the city.

In response to Alder Marks, they discussed neighborhood hiring and said they will collaborate with New Haven Works. In response to Alder Cupo, there was a discussion of parking.
