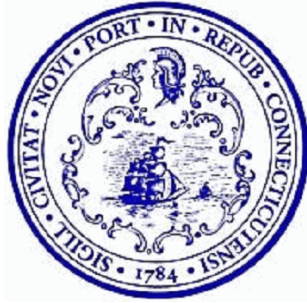

1. ORDER OF THE NEW HAVEN BOARD OF ALDERS APPROVING THE APPOINTMENT OF EDWIN MARTINEZ TO THE CITY PLANNING COMMISSION.

PUBLIC TESTIMONY
