## Minutes

Alder Rosa Ferraro Santana, Chair, called the public hearing to order at 6:02 p.m.

Present were Alders Rosa Ferraro Santana, Chair; Evette Hamilton, Vice Chair; Evelyn Rodriguez; Ron Hurt; and Eli Sabin.

Non-committee members include Alders Gerald M. Antunes, Abigail Roth, and Salvatore DeCola.

### 1. ORDER OF THE NEW HAVEN BOARD OF ALDERS APPROVING THE APPOINTMENT OF BARBARA VEREEN TO THE BOARD OF FIRE COMMISSIONERS.

#### PUBLIC TESTIMONY

Barbara Vereen, 80 Pond Street, spoke of her interest in serving on the Fire Commission. Spoke about how she has been a life-long New Haven resident.

In response to Alder Hamilton, Ms. Vereen spoke about she has reached out and confirmed when the Fire Commission meets, and she is available during those times to attend the meetings.

In response to Alder Sabin, Ms. Vereen spoke about how it is important to her that our firefighters are representative of New Haven.

#### COMMITTEE ACTION

Alder Sabin moved items # 1, 2, 4 as amended, 5, 6, and 7, seconded by Alder E. Rodriguez. All of the Alders spoke in favor of these items. The motion was unanimously approved, and the items passed.

### 2. ORDER OF THE NEW HAVEN BOARD OF ALDERS APPROVING THE APPOINTMENT OF DARRELL BROOKS TO THE BOARD OF POLICE COMMISSIONERS.

#### PUBLIC TESTIMONY

Darrell Brooks, 170 Stevenson Road, spoke of his interest to serve as a Police Commissioner.

In response to Alder Ferraro-Santana, Mr. Brooks confirmed he had attended a training session for the Police Commission and was available to attend the meetings.

In response to Alder Hamilton, Mr. Brooks reviewed his service to New Haven over the years including retiring after 25 years as a firefighter. Spoke of his experience serving the city throughout the years and how he thinks his experience will help him in his service on the Police

Commission. Reviewed how he wants to work with the other commissioners to improve the New Haven Police Department.

In response to Alder Hurt, Mr. Brooks reviewed how the city should have people that look and represent the makeup of New Haven. Spoke of how one of the ways for the city to build trust is to have members of the command structure that represent New Haven and look like the communities' they serve. Reviewed how his experience will help him convey the importance of having a command structure that reflects New Haven.

In response to Alder Sabin, Mr. Brooks reviewed how he does believe that New Haven should have the right to oversee the Yale Police Department. Spoke of how public safety is dear to his heart and he understands the importance of working with the police department as he has worked with them over the years in his role as a firefighter.

Alder Sabin moved items # 1, 2, 4 as amended, 5, 6, and 7, seconded by Alder E. Rodriguez. All of the Alders spoke in favor of these items. The motion was unanimously approved, and the items passed.

Alder Sabin moved to give leave to withdraw to item # 3, seconded by Alder Hamilton. All of the Alders spoke in favor of the item. The motion was unanimously approved, and the item passed.

In response to Alder Ferraro-Santana, Mr. Lee reviewed how he has not attended any meetings and does not know the time but will be available.

In response to Alder Hamilton, Mr. Lee reviewed how he recently became a US citizen and was limited in the past from serving because of his immigration status. Reviewed how he heard about the board from Chris Mordecai, who currently serves on this board.

In response to Alder Sabin, he spoke of his experience as a realtor in Connecticut and New York. Spoke about due to his limited experience serving on boards, he will be deferring to other members and willing to help out as he learns.
