Meeting Minutes

Alder Marchand, Chair called the meeting to order at 6:10 p.m., May 12, 2022 in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Marchand, Hurt, Douglass, Santiago, DeCola, Morrison, Walker-Myers, Hamilton, Festa, Furlow, and Winters. Also present were Alder E. Rodriguez.

To deliberate and act on the City Budget for Fiscal Year 2022 2023 and other budgetary items.

Committee action

1. Alder Marchand, seconded by DeCola, to move items 1 & 2, Appropriating Ordinance #1 and #2. For discussion.

a. Alder Marchand made a motion to discuss a Technical Amendment, concerning changes to Appropriating Ordinance #1 and #2, to the committee. Alder Marchand, seconded by Morrison, made a motion to approve the Technical Amendment. The committee unanimously voted by voice vote, to approve the Technical Amendment.

b. Alder Marchand, seconded by DeCola, made a motion to discuss the Marchand/Hurt amendment. Alder Marchand went over the proposed amendment.

Alder Morrison spoke concerning the proposed Library position changes.

Alder Furlow spoke about reducing the number of Neighborhood Specialists in LCI.

Alder Walker-Myers spoke concerning the reduction in the Board of education budget amount.

Alder Winter spoke about moving funds from the Expenditure Reserve to the Medical account.

The committee voted, by voice vote, to unanimously approve the Marchand/Hurt amendment.

c. Alder Festa, seconded by Winters, made a motion to amend Ordinance #1 by using ARPA funds for two years to fund 2 positions.

Alder Walker-Myers spoke against this amendment.

The committee had further discussion concerning this amendment.

The committee voted on this amendment. The results were Aye- Alder Festa, Nay-Alders Marchand, Hurt, Santiago, DeCola, Morrison, Walker-Myers, Hamilton, Furlow, and Winters. The amendment failed to pass.

d. Alder Winter, seconded by Festa, made a motion to amend Ordinance #1 to reduce the Police Department Uniforms by \$100,000 and move these funds to Expenditure Reserve. The committee had a discussion concerning the amendment. Alder Winter withdrew his amendment.

e. Alder Marchand, seconded by DeCola to move item 1 and 2, as amended. Alders

Marchand, Winters, Festa, Walker-Myer, Hamilton, Furlow spoke concerning the amended ordinances. A voice vote was taken and those voting Yea – Alders Marchand, Hurt, Santiago, DeCola, Morrison, Walker-Myers, Hamilton, Furlow, and Winters, Nay – Alder Festa. Appropriating Ordinance 1 and 2, as amended were approved.

2. Alder Marchand, seconded by DeCola, moved item 3.

a. Alder Marchand made a motion to discuss a Technical Amendment, concerning changes to the Redesignation section of the Ordinance. Alder Marchand, seconded by Morrison, made a motion to approve the Technical Amendment. The committee unanimously voted by voice vote, to approve the Technical Amendment.

b. Alder Festa, seconded by Winter, made a motion to amend Ordinance #3 by removing from the language "or restructure Service". Alder Walker-Myer and Alder Hamilton spoke against the amendment. Alder Winter spoke in favor of the amendment. The committee had a voice vote on the amendment. The votes were Yea – Alder Festa and Winter, Nay -Alders Marchand, Hurt, Santiago, DeCola, Morrison, Walker-Myers, Hamilton, and Furlow. The amendment failed.

c. Alder Marchand, seconded by DeCola, moved the amended item for a vote. The committee voted, by voice vote to approve Appropriating Ordinance #3.

3. Alder Marchand, seconded by DeCola, made a motion to move item 4. The committee voted by voice vote to approve Ordinance Amendment #4.

4. Alder Marchand, seconded by DeCola, made a motion to move item 5. Alder Marchand spoke to the committee concerning a technical amendment requested by the administration. The committee unanimously voted, by voice vote, to approve the technical amendment.

Alder Marchand, seconded by Furlow, made a motion to approve item 5, as amended. The committee voted, unanimously, by voice vote, to approve the Ordinance Amendment to Section 17 201 of the general code of ordinances authorizing additions and changes in permits, licenses and user fees.

At 8:00 PM, on a motion by Hurt, seconded by Morrison, the Committee voted to close the meeting.

The meeting was recorded. The recording is filed and may be inspected at Legislative Services.
