Meeting Minutes

Alder Marchand, Chair called the meeting to order at 6:10 p.m., June 13, 2022 in the Aldermanic Chamber, 165 Church Street, New Haven. Present were Alds. Marchand, Hurt, Douglass, Santiago, DeCola, Morrison, Walker-Myers, Hamilton, Festa, Furlow, and Winters. Also present were Alder E. Rodriguez.

ORDER APPROVING AN AMMENDMENT TO A LEGAL SERVICE AGREEMENT

Michael Gormany, Acting Controller, Patricia King, Corporation Counsel, came before the committee. Mr. Gormany spoke on this request followed by Ms. King.

- 2. Alder Hurt, seconded by Morrison, made a motion to move item 2. The committee voted unanimously to approve the April Monthly Report for Read and File.

At 6:45 PM, Alder Marchand opened the meeting as a workshop.

Mr. Gormany spoke to the committee, followed by Mr. Piscitelli, Ms. Jefferson, Mr. Zinn, Ms. Williams, and Dr. Dalal.

Alder Santiago asked for a list of parks for the last two years. Mr. Zinn said he would get this list to the committee.

There were no further questions.
