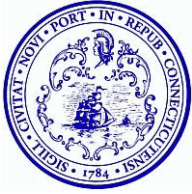

Thank you for your letter from Connex and for your voicemail regarding the check mailed by Connex and the interest applied to your account due to the City of New Haven Tax Office not receiving payment by August 1, 2025.

According to Connex, a payment was scheduled, processed, and mailed to the City of New Haven Tax Collector's Office at P.O. Box 1927. Unfortunately, we are unable to determine what may have occurred between the time the payment was mailed by Connex and its delivery to the Tax Office. Please note that all mail received by our office is processed daily.

The Tax Office is governed by Connecticut State Statutes, which do not grant the Tax Collector the authority to waive interest. However, if the original check is later received by the Tax Office and is dated as an on-time payment, the interest charged will be credited toward your next installment.

Good morning, Mr. Buckholz

I will not be available tomorrow. I have reviewed your account and the related notes from one of my staff members who spoke with you. According to the notes, a payment was sent from Connex; however, the Tax Office did not receive the payment, and the check has not been cashed.

Unfortunately, the Tax Collector does not have the authority to waive interest under Connecticut State Statute. Liens have been placed on all delinquent real estate accounts; however, your account is currently paid in full for the July 2025 installment and has not been lien.

If the check resurfaces and it is confirmed that the payment was made on time, the interest will be credited to your next installment due in January 2026.

Please let me know if there are any other matters regarding your real estate account that require attention.

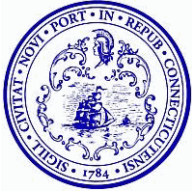

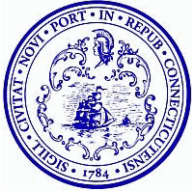

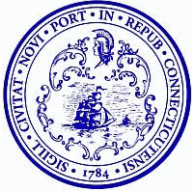
