WHEREAS, the City of New Haven recognizes the importance of ensuring used syringes are properly removed and disposed of from public locations; and,

WHEREAS, upon securing syringe removal and disposal services, the City can help minimize the risk of transmission of blood-borne pathogens to residents.

NOW, THEREFORE, BE IT ORDERED by Board of Alders of the City of New Haven that the Mayor, on behalf of the City, is authorized to enter into a one-year contract in the amount of \$25,000 with Yale School of Medicine. and to execute any revisions, amendments or modifications to said contract.
