ORDINANCE AMENDMENT OF THE BOARD OF ALDERS OF THE CITY OF NEW HAVEN AMENDING ARTICLE VII. - BUDGETARY AND FINANCIAL ADMINISTRATION SEC. 2-376, SEC. 2-451, SEC. 2-481 - 2-488, AND SEC. 2-385 - 2-386 OF THE CITY CODE OF ORDINANCES (PURCHASING ORDINANCE).

WHEREAS: the Mayor of the City of New Haven Board desires to amend Article VII - Budgetary and Financial Administration, Sec. 2-376, Sec. 2-451, Sec. 2-481 through 2-488, and Sec. 2-385 to 2-386 of the City code of Ordinances (the Purchasing Ordinance) to clarify, streamline and update the City's procurement procedures; and

WHEREAS: the Mayor submits the proposed ordinance amendments herewith which are incorporated herein by reference; and

NOW THEREFORE BE IT ORDAINED, by the Board of Alders of the City of New Haven that the proposed amendments to the Purchasing Ordinance incorporated herein by reference be and are hereby approved.
