ORDINANCE AMENDMENT OF THE BOARD OF ALDERS OF THE CITY OF NEW HAVEN AMENDING ARTICLE VII. - BUDGETARY AND FINANCIAL ADMINISTRATION SEC. 2-376, SEC. 2-451, SEC. 2-481 - 2-488, AND SEC. 2-385 - 2-386 OF THE CITY CODE OF ORDINANCES (PURCHASING ORDINANCE).

WHEREAS: the Mayor of the City of New Haven Board desires to amend Article VII - Budgetary and Financial Administration, Sec. 2-376, Sec. 2-451, Sec. 2-481 through 2-488, and Sec. 2-385 to 2-386 of the City code of Ordinances (the Purchasing Ordinance) to clarify, streamline and update the City’s procurement procedures; and
