ORDER OF THE NEW HAVEN BOARD OF ALDERS AUTHORIZING THE CITY OF NEW HAVEN (MAYOR, CONTROLLER OR BUDGET DIRECTOR) TO EXECUTE A SIX-MONTH NO-COST CONTRACT EXTENSION FOR THE UNIVERSITY OF NEW HAVEN'S CONTRACT # 2023-CON-0288, WHICH IS TO CONDUCT A FORMATIVE AND PROCESS EVALUATION OF THE VIOLENCE REDUCTION PROGRAM FOR REINTEGRATION, ENGAGEMENT, SAFETY AND SUPPORT (PRESS).

WHEREAS, the City of New Haven awarded a contract to the University of New Haven, effective July 1, 2023, with an end date of June 30, 2024; and,

WHEREAS, the University of New Haven was awarded the contract after a panel reviewed the request for proposal application; and,

WHEREAS, the University of New Haven requested time until December 31, 2024, to complete the evaluation due to unforeseen delays; and,

WHEREAS, the formative and process evaluation of the violence reduction initiative PRESS is vital to ensure that resources are being used appropriately; and,

WHEREAS, the City is seeking approval to execute a six-month non-cost extension for the University of New Haven's contract #2023-CON-0288.

NOW, THEREFORE, BE IT ORDERED by the New Haven Board of Alders that the City Mayor, Controller, or Budget Director be authorized to execute a six-month non-cost contract extension for
