RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF NEW HAVEN TO ACCEPT A CONTINUATION OF FUNDING GRANT AWARD FOR THE PER CAPITA GRANT IN THE AMOUNT OF \$260,706.33 FROM THE CONNECTICUT DEPARTMENT OF PUBLIC HEALTH FOR THE PERIOD JULY 1, 2024 THROUGH JUNE 30, 2025 TO ASSIST WITH THE OPERATION OF THE HEALTH DEPARTMENT.

WHEREAS, the City of New Haven Health Department has applied for funding from the Connecticut Department of Public Health; and upon receipt of such grant, the City will accept the grant in its entirety; and,

WHEREAS, the State of Connecticut Department of Public Health has issued a continuation Per Capita funding application, intended to continue to support the operation of the Health Department; and,

WHEREAS, the New Haven Health Department is seeking to continue to receive Per Capita funding in the amount of approximately \$260,706.33.

NOW, THEREFORE, BE IT ORDERED THAT the Mayor is authorized to execute said in the amount of about \$260,706.33 from the State of Connecticut Department Public Health and to execute any revisions, amendments or modifications to said contract.
