ORDER GRANTING LEAVE TO WITHDRAW THE APPROPRIATING ORDINANCE #5 AN ORDINANCE APPROPRIATING NOT EXCEEDING \$250,000,000 FOR DEPOSIT TO THE CITY OF NEW HAVEN'S RETIREMENT PLANS TO FUND A PORTION OF THE CITY'S UNFUNDED PAST BENEFIT OBLIGATION AND AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$250,000,000 TAXABLE GENERAL OBLIGATION BONDS OF THE CITY TO MEET SAID APPROPRIATION FISCAL YEAR 2019.

BE IT ORDERED By The New Haven Board Of Alders That The Communication Titled "Appropriating Ordinance #5 an Ordinance Appropriating not exceeding \$250,000,000 for deposit to the City of New Haven's Retirement Plans to fund a portion of the city's unfunded past benefit obligation and authorizing the issuance of not exceeding \$250,000,000 taxable general obligation bonds of the city to meet said appropriation fiscal year 2019.", and dated March 5, 2018, be and hereby is granted leave to withdraw.
