WHEREAS, Funds from the salary reserve account will be transferred to The Department of Parks/Public Works, Office of Information and Technology, Corporation Counsel, and Community Services Administration salary accounts to cover the difference of for each position change listed above.

NOW, THEREFORE, BE IT ORDAINED by the New Haven Board of Alders that the re-classification of the positions for The Department of Parks/Public Works, Office of Information and Technology, Corporation Counsel, and Community Services be reclassified and funds in the amount of Eighty-Five Thousand, Eight Hundred and Eighty-Two Dollars and Zero Cents \$85,882 be transferred from salary reserve account (1-407-1010-50110) to The Department of Parks/Public Works (1-504-1010-50110), Office of Information and Technology (1-137-1120-50110), Corporation Counsel (1-133-1010-50110), and Community Services Administration (1-308-1010-5010)
