ORDER OF THE NEW HAVEN BOARD OF ALDERS APPROVING THE PAINTING OF SEVERAL CREATIVE CROSSWALKS ALONG CHAPEL STREET IN THE PUBLIC RIGHT OF WAY ALONG THE CHAPEL STREET RAILROAD OVERPASS AND THE INTERSECTIONS ON BOTH SIDES (CHAPEL AND STATE & CHAPEL AND UNION ST). AND AUTHORIZING AND APPROVING A PAINTED MURAL, INSTALLED DIRECTLY ON THE OVERPASS WALL AND ANY OTHER RELATED OR DESIRED IMPROVEMENTS CONSISTENT WITH THE INTENT OF IMPROVING THE PUBLIC RIGHT OF WAY ALONG THE CHAPEL STREET RAILROAD OVERPASS AND THE INTERSECTIONS ON BOTH SIDES (CHAPEL AND STATE & CHAPEL AND UNION ST).

BE IT HEREBY ORDERED that the New Haven Board of Alders approves the painting of several creative crosswalks along Chapel Street in the public right of way along the Chapel Street Railroad Overpass and the intersections on both sides (Chapel and State & Chapel and Union St); and

BE IT FURTHER ORDERED THAT the painting of several creative crosswalks along Chapel Street in the public right of way along the Chapel Street railroad overpass and the intersections on both sides (Chapel and State & Chapel and Union St)," submitted on September 18, 2020, and previously Adopted on December 7, 2020, is hereby amended to provide authorization and approval of a painted mural, installed directly on the overpass wall and any other related or desired improvements consistent with the intent of improving the public right of way along the Chapel Street Railroad Overpass and the intersections on both sides (Chapel and State

& Chapel and Union St).
