ORDER OF THE NEW HAVEN BOARD OF ALDERS AUTHORIZING THE NEW HAVEN PUBLIC SCHOOLS TO ENTER AN AGREEMENT WITH CURRICULUM ASSOCIATES TO PURCHASE K-5 TEXT MATERIALS AND PROFESSIONAL DEVELOPMENT.

WHEREAS: the New Haven Board of Education (the "Board") voted on March 8, 2021 to enter into agreement with Curriculum Associates to purchase Ready Math, MyPath, iReady text and materials for students and teachers in grades K -5; and

WHEREAS: the Agreement covers materials and professional development from July 2021 to August 2026; and

WHEREAS: all print materials will be available in English and in Spanish; and

WHEREAS: the cost provides Universal Screening to stay in compliance with federal and state mandates; and

WHEREAS: the final cost for all materials and services will be \$2,097,576; and

WHEREAS: the sum will be paid for by grants with no monies coming from General Funds by June 30, 2021;

NOW THEREFORE BE IT ORDERED by the Board of Alders of the City of New Haven Agreement is hereby approved; and

that the 2021-2026

BE IT FURTHER ORDERED that the President of the Board of Education or the Mayor is authorized to execute the 2021-2026 Agreement as well as such additional instruments as may be deemed necessary or expedient to implement the terms.
