AND EXECUTE ANY REQUIRED RELATED DOCUMENTS

WHEREAS, Gather New Haven, Inc. is making application to the State Department of Energy and Environmental Protection (DEEP) as project Co-sponsor for an Urban Green and Community Garden Grant in the amount of \$70,000 to make needed improvements to community gardens and preserves under its management; and

WHEREAS, the State Department of Energy and Environmental Protection (DEEP) is authorized by Public Act 2005-228, Sec. 6(3) to make grants to a municipality for this purpose; and

WHEREAS, the City of New Haven supports the efforts of local organizations to promote community gardens and green spaces as a way of revitalizing neighborhoods, and encouraging the preservation of green areas throughout the City.

NOW, THEREFORE, BE IT RESOLVED: by the Board of Alders of the City of New Haven approves acceptance of the DEEP grant funds on behalf of Gather New Haven, Inc. and authorizes Mayor Justin Elicker to sign the grant agreement with the State on behalf of the City; and

BE IT FURTHER RESOLVED: that Mayor Justin Elicker is authorized to execute any required paperwork to pass these funds on to Gather New Haven, Inc. to be used in accordance with the grant requirements.
