WHEREAS, Christopher Martin's hosts the Annual Christmas Run for the Children - 5K to benefit local charities;

WHEREAS, the route will start at State Street heading south, turn right onto Chapel Street, turn right onto Orange Street, turn left onto Audubon Street, turn left onto Whitney Avenue (becomes Church Street), turn left onto Chapel Street, turn left onto Olive Street, turn left onto Court Street, turn right onto State, continue to finish. The route will be closed to traffic as the race travels through and will re-open as the participants clear an intersection;
