RESOLUTION OF THE BOARD OF ALDERS CERTIFYING THAT NO AMENDMENT TO THE YALE UNIVERSITY CENTRAL/SCIENCE CAMPUS OVERALL PARKING PLAN IS REQUIRED FOR THE APPLICATION FOR DEVELOPMENT PERMIT/SITE PLAN REVIEW PERTAINING TO THE EXPANSION OF LOT 15 ON THE YALE UNIVERSITY CENTRAL/SCIENCE CAMPUS WHEREAS, by communication dated September 22, 2023 from J. Michael Bellamy, Vice President, Facilities and Campus Development, Yale University has requested that the Board of Alders approve a resolution by unanimous consent certifying that an amendment to Yale University's Central/Science Campus Overall Parking Plan is not required for the Application for Development Permit/Site Plan review submitted to the City Plan Commission on September 21, 2023 pertaining to the Yale University Central/Science Campus; and

WHEREAS, the Application for Development Permit/Site Plan review involves the expansion of an existing Yale University parking lot known as Lot 15 located at 339 Prospect Street within the University's Central/Science Campus, all as set forth more particularly in the communication submitted by Yale University.
